First Aid

General Information

AGRI-STAR is a specialized water conditioner and pH acidifier that mitigates hard water mineral antagonism of herbicide spray mixes.

AGRI-STAR contains water conditioning agents that improve the performance of certain herbicides by maintaining the quality of the spray water.

AGRI-STAR reduces off-target drift and enhances spray deposition and canopy penetration by providing a more uniform spray pattern.

AGRI-STAR contains a nonionic surfactant to optimize wetting and spreading onto the targeted leaf surface.

AGRI-STAR contains free fatty acids to improve rainfastness and wash-off resistance.

The antifoam ingredient in AGRI-STAR suppresses troublesome foam in tank mixes.

Storage and Disposal

Do not contaminate water, food or feed by storage or disposal of this product.

Storage: DO NOT FREEZE! Do not store below 40°F or above 120°F. Keep cool. Store in tightly closed original container. Keep in a dry, well ventilated area away from excessive heat and incompatibles (oxidizing agents).

Directions For Use

Always read and follow adjuvant use instructions found on the pesticide label before using. For use with pesticides registered for use for agriculture, forestry, industrial municipal, non-cropland and right-of-way.

Do not use AGRI-STAR with sulfonamide herbicides or sulfonylurea herbicides or other mixtures that cannot tolerate low pH levels.

Use Rates: Use 2 quarts (0.50% v/v) to 3 quarts (0.75% v/v) of AGRI-STAR in 100 gallons of spray water. For enhanced deposition and drift suppression, use the higher rate.

Mixing Instructions

Unless otherwise instructed by pesticide label, fill the spray tank one-half full with water and begin agitation. Add AGRI-STAR and continue agitation. Continue filling the tank adding pesticides and fertilizers as directed by product labels.
